Lee D. Hoffman to speak on -"Lessons Learned from the Two Storm Panel: Limiting Future Natural Disasters"

Lee Hoffman served as a member of the Two Storm Panel charged by Governor Dannel P. He has served on many forums- many in leadership rolesincluding the Governor's Energy Policy Working Group, the Connecticut General Assembly's Task Force on Brownfield Strategies, CBIA's Environmental Policies Council and the Environmental and Public Utilities Sections of the Connecticut Bar Association. Lee Hoffman is a director of the New England Section AWMA, as well as Chair of the Environmental Policy Division of the Technical Coordinating Council of International AWMA.
