

A POSITIVE TREND IN HEALTH CARE

Ambulatory Surgery Centers

During the past year, our new health care attorneys were at the forefront of representing clients in mergers and acquisitions as well as in a host of regulatory matters in the ever-growing ambulatory surgery center sector.

- We worked on the certificate of need (CON) proceedings and sale of an ambulatory surgery center to Merritt Healthcare and a group of physician investors in Bloomfield, CT.
- We represented a diverse group of 23 specialists investing in the Waterbury-based Naugatuck Valley Ambulatory Surgery Center in another deal in which Merritt



Healthcare also participated as the management company and as a significant equity participant.

- We represented a physician buyer and a joint venture entity in the acquisition of a facility that will lead


to the creation of the Greater New Haven Ambulatory Surgery Center located in Hamden, CT.

- We assisted Bridgeport Hospital in the sale of its equity interest in the Surgery Center of Fairfield County to Surgical Care Associates.

Throughout these engagements and others, we handled a variety of complex relocation, facility licensure and managed care contracting matters for clients. Our attorneys also advised on regulatory issues surrounding Connecticut's adoption of a 23-hour stay regulation for ambulatory surgery centers and the imposition of a provider tax on these facilities.

ASSISTING CARE FACILITIES

Nursing Homes Face Financial Challenges



In 2016, our bankruptcy team successfully transitioned Hebrew HealthCare's 257 bed nursing facility in

West Hartford to a new owner as part of its bankruptcy reorganization process. Hebrew HealthCare and

its four affiliates filed for Chapter 11 in August and immediately sought permission from the Bankruptcy Court to sell its skilled nursing facility. As with many skilled nursing facilities, Medicare and Medicaid rates were not keeping pace with the actual cost of providing care to its patients and residents. In December, the Bankruptcy Court approved the sale of the skilled nursing facility to The Hebrew Center for Health and

Rehabilitation, an affiliate of National HealthCare Associates.

The sale of the nursing home puts the remaining Hebrew HealthCare businesses, consisting of a hospital, an assisted living facility, a community-based geriatric program and a doctor's group, in a position to emerge from bankruptcy and operate as profitable businesses.

PROTECTING TRADEMARKS

The Connecticut Health Insurance Exchange

“Access Health CT” is the business name and registered trademark for the Connecticut Health Insurance Exchange – the state’s health insurance marketplace established under the Affordable Care Act (ACA). Most consumers recognize Access Health CT by the bright yellow and orange logo used to introduce the Exchange to the public, but some individuals search for the Exchange on the Internet using terms such as: “Connecticut insurance exchange” or “CT health insurance exchange.” Some businesses selling insurance have chosen names and website addresses to capitalize on this practice, even designing their websites to look similar to a state health insurance marketplace, in the hope of convincing unwary consumers that they should buy insurance plans using their portal or brokers.

Often, these plans are not the best plans for the consumer. In addition, consumers who purchase plans outside of Access Health CT are not eligible for any subsidies they might otherwise be entitled to under the ACA because subsidies are only available for plans purchased through the official Exchange.

Since the Exchange was established in 2012, our attorneys have assisted the Exchange in preventing these deceptive practices that can cause considerable harm to consumers. We have challenged violators under federal trademark and unfair competition laws, as well as state insurance laws. Our efforts are ongoing, since each year new opportunists surface, but thus far we have been successful in stopping all violators we have pursued.

OVERSEEING PATIENT CARE

Conservatorship and Commitment Matters

Attorneys from our Trusts and Estates, Health Care and Litigation practices supervise and handle conservatorship and commitment matters for several large hospitals. When a patient is mentally or physically unable to manage his or her personal or financial affairs, our team secures appointment of conservators in probate court to make medical decisions and safe discharge arrangements on behalf of the patient and handle his or her financial matters, including obtaining public benefits. For patients with psychiatric illnesses, our team manages involuntary commitment proceedings to ensure that patients receive the care and treatment that they need at appropriate mental health facilities.

BOND COUNSEL FINANCING

Senior Health Care Provider Positioned for Growth



In November 2016, the firm’s Government Finance practice served as bond counsel to the State of Connecticut Health and Educational Facilities Authority on its \$115,785,000 Revenue Bonds, Masonicare Issues, Series F and G. Masonicare is the largest provider of senior health care, senior living, homecare and hospice in Connecticut.

The financing enabled Masonicare to take advantage of historically low tax-exempt interest rates and terminate prior swaps. Because of the complex structure of the transaction, the firm handled a variety of substantive questions on the deal, including Masonicare’s 501(c)(3) status, disclosure law issues relating to certain ongoing investigations at Masonicare, “qualified hedge” issues under the tax code relating to the swaps, and various variable rate, refunding, escrow and management contract tax issues. We worked closely with the Authority, Masonicare, the underwriter, letter of credit providers, the bond trustee and their respective counsel to help bring this issue to a successful and expedient closing.

Restructuring the USTA's Digital Platform

Pullman attorneys partnered with USTA in-house counsel, finance,

and technology staff to shepherd the negotiations to a successful conclusion. Over the next year, USTA will not only roll out a new public-facing site, but will also rebuild its underlying infrastructure, including its web content management system as well as its analytics and member database platforms. With its innovative design and features, the new website will be a boon to tennis fans everywhere.

NORTH AMERICAN MARKET GROWTH

illy's Successful Expansion Continues



During the last several years, the firm has enjoyed working with illy caffè North America, a subsidiary of the family-owned coffee company illy caffè S.p.A., based in Trieste, Italy, as it continues its successful expansion in the North American market. Our attorneys have assisted illy in many different types of matters contributing to its growth, including real estate leasing work for its

retail coffee shops, a wide variety of contractual agreements, and internet compliance issues involving privacy policies and Terms of Use for illy's United States website.

In 2016, illy signed its largest global client, United Airlines, and became the official coffee provider to North America's third largest airline. To make this a reality, our attorneys were instrumental in facilitating illy's capital investment by orchestrating all the legal activities surrounding a significant loaned equipment agreement with United. Today, more than 30 airport lounges and 5,000 daily flights serve illy, which equates to more than 70 million cups of coffee each year.

LONG-LASTING CLIENT PARTNERSHIP

Representing Three Generations of Business Owners

For nearly 50 years, our firm has assisted Encon with smooth transitions in its ownership spanning three generations of business owners.

Our relationship with Encon began in 1970, when a licensed engineer and entrepreneur formed the company to provide design, installation and service for heating and air conditioning systems. The owner's business philosophy was to provide "quality, quality and more quality" for his customers and he instilled this philosophy in his employees.

When the time came for the founding entrepreneur to create an exit strategy, we determined that the best alternative for him was to sell the business to two key employees in a leveraged buyout. With appropriate conflict waivers, we represented the purchasers and continued to represent the founder in his other matters.

As is the case in virtually all leveraged buyouts, it was advantageous for the employee-purchasers only if they could grow the business significantly and increase its value. When they accomplished this and began to consider their future exit strategy, we worked with them to develop a program to retain two key employees and incentivize them to purchase the business in a second leveraged buyout.

When those employees purchased the business, we continued to represent the business and the purchasers, so that we then represented all three generations of the owners. The third owners of Encon continued to grow the business dramatically, and in 2016 we counseled them in the company's sale to a private equity group.

UNIVERSITY PURCHASES FORMER CORPORATE HQ

Environmental Evaluation Assists Sacred Heart Expansion

On December 16, 2016, Sacred Heart University, with the assistance of Pullman & Comley attorneys, purchased the 66-acre former General Electric world headquarters in Fairfield. The \$31.5 million purchase has been described by University President John J. Petillo as "...a transformational moment in the history of Sacred Heart University." The University plans to use the property as an innovation campus; to expand its new School of Computing, which is focused on computer engineering, computer gaming and cybersecurity; and to develop programs in STEM fields such as health and life sciences, science and technology. The University will also move certain elements of its Jack Welch College of Business to the new campus, including its new hospitality management program.

Our environmental attorneys worked closely with Sacred Heart University

Secretary and General Counsel, Michael D. Larobina, to ensure that the University had full access to the site to conduct comprehensive due diligence. With the assistance of the University's environmental consultants, we evaluated the complex environmental issues related to the site, negotiated with the GE project team regarding state and federal compliance issues, including those under the Transfer Act and RCRA, and drafted documents that accurately reflected the agreement of the parties on the allocation of responsibility for compliance, which was especially important due to the post-closing obligations retained by GE. We also made recommendations to the University to significantly limit any environmental risk. Despite the complexities and size of this transaction, the parties were able to successfully close within approximately three months of the beginning of negotiations.



MOVING BEYOND DISPUTE RESOLUTION

Investing in Green Energy



Clean Feet Investors is a Connecticut-based investment fund dedicated to investing in green energy projects. In 2016,

we were retained by Clean Feet to assist in its investment activity. At the time, the fund was working on a number of significant investment opportunities and also resolving a dispute with a company that operated and maintained some of Clean Feet's solar projects. In 2016, this dispute reached a boiling point, threatening the projects' viability and cash flow. Utilizing our significant knowledge of the alternative energy business and our extensive experience in corporate transactions, our attorneys assisted Clean Feet in re-taking possession and control of the projects and structuring a deal that allowed Clean Feet to obtain control over a significant portfolio of projects. This increased Clean Feet's potential revenue from the combined projects while maintaining their ongoing benefits. Beyond this dispute resolution, our firm has been able to assist Clean Feet with a number of other projects ranging from Solar PV installations to battery storage.

CHERRY STREET LOFTS

Factory Conversion Revitalizes Industrial District

The firm's Government Finance and Real Estate practices have been instrumental in the initial transformation of a blighted industrial property along Interstate 95 in Bridgeport. Once the site of the former North American Phonograph Company, which set the stage in the mid-1890s for the modern recording industry, the buildings were vacated in the 1980s, leaving the property to fall into decay.

In the first phase of the transformation, two of the eight buildings will be demolished and the environmentally contaminated brownfield site will be remediated. Rehabilitation of some of the remaining structures and construction on 157 residential apartments has begun, making this the first multifamily housing construction in the area in more than a decade. A community facility, a gym and a 40,000 square-foot outdoor recreational space will also be constructed on the site. Plans for the next phase of construction include an additional 150 apartments, a new home for the Great Oaks Charter School, and housing for the school's tutors.

Our attorneys worked with the developer for two years to assemble the property for the project and to close a multi-party financing transaction in order to repurpose the site. The property assembly included three parcels owned by



different entities, including the City of Bridgeport, as well as numerous easements, street abandonments and permits to facilitate parking for the project. We worked with the city and the developer to implement a favorable property tax incentive for the project. Our attorneys facilitated financing for the project from numerous sources, including: construction and permanent financing from the Connecticut Housing Finance Authority (CHFA) through a conduit bond financing; a Brownfields loan from the Connecticut Department of Economic and Community Development; a grant from the city; and the sale of federal and state historic tax credits. The bonds issued by CHFA were purchased by the AFL-CIO Housing Investment Trust, a pension trust owned by the AFL-CIO in the first-of-its-kind financing in Connecticut. The financing was completed in November, 2016, and the initial phase of the project is expected to be ready for occupancy in mid-2018.

McLEVY SQUARE'S TRANSFORMATION

Downtown Bridgeport's Renaissance Continues

An interdisciplinary team of our Government Finance and Real Estate attorneys represented Forstone Capital in the renovation of McLevy Square, a four building, half-acre, historic site located in the heart of downtown

Bridgeport overlooking McLevy Green, the city's downtown public green space. This complex transaction, completed in May of 2016, was financed with the sale of federal and state historic tax credits; a construction/term loan from a bank; an affordable housing loan from the State Department of Housing; and a Brownfields loan from the State Department of Economic and Community Development. The completion of the project required a

team effort to close the tax credit transactions, secure state financing for the project, complete the construction loan, negotiate the construction contract, provide advice regarding sales tax exemption for historic rehabilitation work, and finalize all local approvals for the project with the city.

The rehabilitation project transforms this once iconic block into a vibrant, mixed-use complex adding 32 apartment units, a German beer hall, a premier comedy club venue and a commercial/restaurant space. The three new commercial uses will create a much-needed regional draw to the area, and will add approximately 60 to 85 new employees to the downtown workforce.

PULLMAN & COMLEY PLAYS CRITICAL ROLE

Attracting International Companies to Connecticut



With its proximity to New York and Boston, high standard of living and talented workforce, Connecticut is an attractive state for international companies looking to land in the United States. The State of Connecticut, led by the Department of Economic and Community Development with assistance from Connecticut Innovations, the Connecticut Economic Resource Center (CERC), the MetroHartford Alliance, the Jewish Federation of Greater Hartford and private businesses, is taking advantage of these attributes by launching a coordinated effort to attract its share of international companies. Pullman & Comley is proud to be one of the founders and leaders of this effort.

Launched originally as an effort to forge relationships between Connecticut and international companies, the MetroHartford Alliance's Global Business Council teamed with the Jewish Federation of Greater Hartford to introduce Israeli companies to the benefits of building their U.S. business in Connecticut. Our attorneys were at the forefront of this effort, leading the Global Business Council's Israel Subcommittee. Together, we have attracted a number of Israeli companies to Connecticut.

Building on this model, CERC has taken the leading reins of this effort and extended it to companies from Brazil, China and European countries. We continue to support these companies by offering our guidance to CERC through our board membership and to the MetroHartford Alliance through our ongoing leadership on the Global Business Council. We look forward to working with all of these organizations as they contribute to the bright future of Connecticut, and are proud to be representing a number of international companies as they launch their business, hire employees, and make Connecticut their home in the United States.

KEEPING THE POWER ON

Improving the Dependability of Electric Power

Groton, Connecticut is home to one of Pfizer Inc.'s largest research facilities in the United States. This is a significant corporate asset, and after incidents when the facility unexpectedly lost power, Pfizer felt that it needed to improve the dependability of electric power at the site beyond the current sources that included on-site generation and power from the local utility. Pfizer turned to Fuel Cell Energy to install two fuel cells on the site. As part of the installation, Pfizer had to add the fuel cells to its



on-site generation, interconnected to the utility grid in Groton. As these were the first fuel cells installed in a municipally-owned electric utility territory in Connecticut, the project and interconnection requirements created first impression issues that none of the parties had anticipated. As counsel

to Pfizer in the matter, Pullman & Comley worked with both the local utility and Fuel Cell Energy to negotiate an interconnection agreement that allowed the fuel cells to be successfully installed on schedule. The interconnection agreement required unique, out-of-the-box thinking and drafting to ensure that it satisfied the needs of all of the parties involved, including Pfizer, Fuel Cell Energy and its investors, the municipally-owned utility, and the utility's power supplier.

PROPERTY TAX AND VALUATION

Expanding Our Footprint in New England

In 2016 Pullman & Comley's Property Tax and Valuation practice continued its regional expansion. With attorneys licensed in Massachusetts as well as Connecticut, the ability to practice in front of the New Hampshire Board of Tax & Land Appeals, and co-counsel relationships in Rhode Island, we have been able to provide a full complement of property tax and valuation services to property owners and taxpayers with real estate and personal property holdings throughout most of New England.

BROWNFIELD LAND BANK

Offering Municipalities New Hope for Polluted Properties

Pullman & Comley has taken the lead in proposing innovative legislation to form a state-certified brownfield land bank that creates a valuable new tool for municipalities seeking to remediate and redevelop brownfield sites. Despite the great strides made by the state to reduce the barriers to brownfield remediation, a large number of municipalities have remained reluctant to acquire and redevelop brownfield sites, discouraged by internal challenges such as compliance with procurement and sale ordinances, uncertain costs, public safety concerns and political considerations. Additionally, many communities simply do not have the expertise to take on this task.

The new land bank legislation creates a viable remediation alternative for municipalities and adds another important tool to the state's brownfield redevelopment tool box. It provides a certification process for qualified non-stock corporations to acquire, manage, clean up and reposition brownfield sites for redevelopment on behalf of municipalities. In many ways, this legislation is unique and will place Connecticut at the forefront of the brownfield land bank movement throughout the country.

CYBERSECURITY COUNSELING

A Growing Global Concern



As cybersecurity and data privacy have emerged as critical concerns for both large and small businesses, we have responded by providing broad-based cybersecurity counseling that includes proactive risk mitigation, incident response and litigation. FAMILY LAW HANDLES SIGNIFICANT CASES

Supreme Court Victories Have Far-Reaching Impact

In 2016, the Connecticut Supreme Court heard only four family law cases. Of those cases, Pullman & Comley's Family Law attorneys argued, and were victorious, in two. In the first groundbreaking decision, our attorneys overturned a ruling which would have prevented custodial parents from obtaining an upward modification of child support based on an increase in the non-custodial parent's income. The effects of this Supreme Court win were far-reaching and will impact thousands of families in the years to come.

In the second case, our attorneys' actions resulted in a decision that consisted of three separate opinions from the Supreme Court that involved the enforceability, interpretation and application of a prenuptial agreement. This case is significant in that it helped to define how lump sum alimony payments are awarded. It resulted in a lump sum alimony payment of \$7.5 million to our client in addition to the multi-million dollar property distribution set forth in the prenuptial agreement and periodic alimony payments of \$40,000 per month.

FAMILY LAW TEAM CONTINUES GROWTH

In July 2016, Retired Appellate Court **Judge Anne C. Dranginis**, a highly regarded and recognized negotiator and litigator who served for more than 21 years on the Superior and Appellate Court benches, joined our growing Family Law practice. Judge Dranginis focuses on litigation matters involving matrimonial law, corporate compliance and governance, trial strategy, appellate law, arbitration and mediation. In addition to Family Law, she is also a member of the firm's Alternative Dispute Resolution (ADR) Practice. REAL ESTATE PARTNERSHIP DISPUTE

Defending Our Clients' Interests

Our Litigation attorneys assisted investors in Branford Manor Associates, L.P. in a complex intra-partnership dispute involving corporate governance, business tort, tax, trust, housing regulation, and injunction issues. After some 45 years of operating a 1,100-person affordable housing complex in New London together, the second- and third-generation family offices comprising the partnership could not agree on how to wind up the business. When our clients, the general partner and several of the limited partners, resolved to sell the more than \$40 million property, a group of opposed partners brought suit to enjoin the sale and to force a buyout of our clients' interests, so that they could pursue a tax-advantaged exchange without our clients' participation. In a multi-day trial, we vigorously defended the general

partner's right to sell the property. After prevailing on the injunction claim, we pursued a counterclaim of our clients' own for judicial dissolution of the partnership, and worked with our clients' out-of-state counsel to coordinate defense of a second lawsuit the other partners opened in New York. After the other side's options were progressively cut off, the parties agreed to settle the matter on terms favorable to our clients.

Court Dismisses Qui Tam Action

Attorneys in our Litigation practice represented a construction management company that handled a construction project for a housing authority. The project was funded by a federal grant and revitalized public housing in Hartford's North End. A sub-contractor that submitted an unsuccessful bid for the project later sued our client under the Federal False Claims Act, alleging that our client engaged in a fraudulent kickback scheme and obtained improper fees. The plaintiff demanded more than \$2 million in damages. Our attorneys moved to stay discovery, which the court granted, and then filed a motion to dismiss. The court granted the motion to dismiss in its entirety and dismissed the case with prejudice. The case was concluded without our client having to pay any damages or comply with the extensive discovery sought by the plaintiff.
